**Stile Società Cooperativa** intends to operate always in collaboration and partnership with customers and suppliers, as well as employees and associates.

**Stile Società Cooperativa** has as primary objectives the quality of its products and of the service provided, the continuous improvement of our performances in compliance with the requirements of the regulation UNI EN ISO 9001 in the most recent applicable version and with the schemes to which it adheres and which at present are: ISO 9001 certification from CSI of the quality management system since 2002; CE marking in compliance with EN 14342:2005+A1:2008.

**Stile Società Cooperativa** is very responsive to environmental issues and takes them into consideration in all phases of its activity.

One of the factors contributing to the environmental safeguard is the research of wood coming from certified forests. In this respect Stile has obtained certifications according to the FSC schemes. **Stile Società Cooperativa** declares that it is not directly or indirectly involved in the following activities:

- ✓ Illegal cutting or trade of illegal wood or other forestry products
- ✓ Violation of human and traditional rights in forestry operations
- ✓ Destructions of High Values of Conservation in forestry operations
- ✓ Significant conversion of forests into plantations or different soil's use other than forestry
- ✓ Introduction of genetically modified organism in forestry operations
- ✓ Violation of any of ILO's fundamental convention, as defined in the ILO's Declaration on Principles and Fundamental Labour Rights (1998)

The company believes that rationalization of resources, both human and instrumental, should always be pursued in order to guarantee efficient operation and ensure maximum **customer satisfaction**.

The Management shall define clear targets formalized in specific documents by the RDQ, continuously monitored and reviewed at least once a year by the managing team in occasion of the System's review.

It is down to the **Management** to ensure that employees keep an engaged and proactive role within the system, as the contribution of anyone who can identify issues, within their specific fields, and suggest possible resolution and improvements is considered precious.

It is **Management** duty to keep members of staff informed and updated through direct contacts, documentation and activities delegated to the person responsible for the **Quality Management System**. It is duty of the **Management** to respect and give evidence of what has been implemented to safeguard the health and safety of Stile's staff.

In order to implement and materialize the principles outlined in this Policy, it is necessary to have the active and constant participation of all members of staff, that are bound to know and put into practice the guidelines received.
